IMPORTANT:

- ✓ Copyright needs to be observed and respected in all aspects of the creative arts. The tracing of images is not allowed. The copying of existing images for the development of technique as used in the training process of students will be accepted, provided that this source is fully acknowledged in the *Declaration of Own Work* that needs to be submitted with each art entry. (NB Attach a photocopy with full details of any source material)
- ✓ Adult assistance: Adjudicators do encounter artwork that surpasses the expectations in an age group. To distinguish between these candidates and instances of *adult assistance*, it is important to declare any adult assistance in the making of the artwork. (Adult assistance in this context implies that the *hand* of an adult was *actively involved* in the making of the artwork / creative writing / music composition.)
- ✓ When submitting multiple entries, please ensure that the item number, item description and theme / name of the artwork on the printed declaration form corresponds with the artwork! (Do not mix up the forms and art works!)
- ✓ Submitting the artwork attached to this form constitutes a declaration that this artwork is the participant’s own creation.
- ✓ **Please complete and sign the DECLARATION OF OWN WORK (see below) and attach this page to the back of your artwork (or any suitable place).**
- ✓ **Kindly note that the NEA will not accept any artwork for adjudication without this Declaration of Own Work.**
